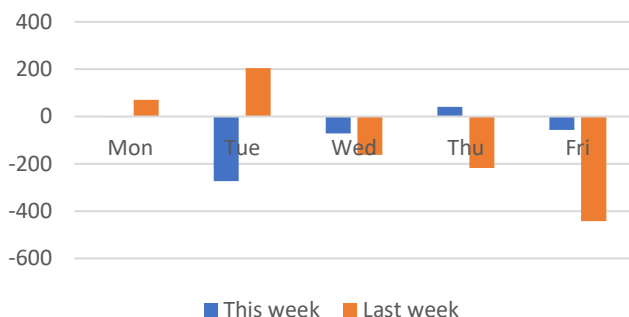

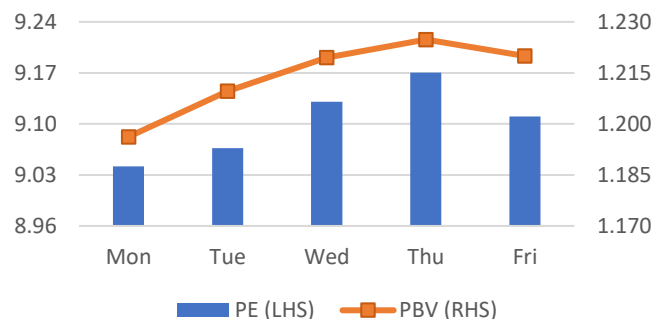
S&PSL20 movement



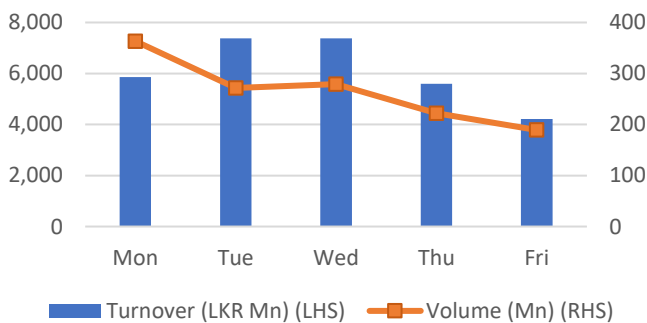
CSE - Net Foreign Inflow/ Outflow (LKR Mn)



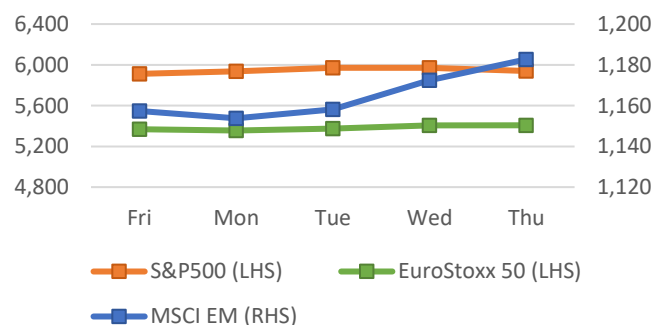
Market PE and PBV

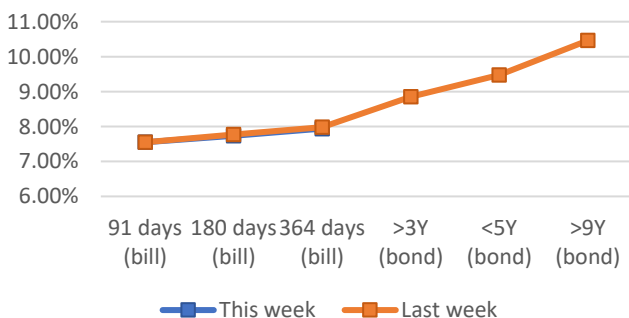

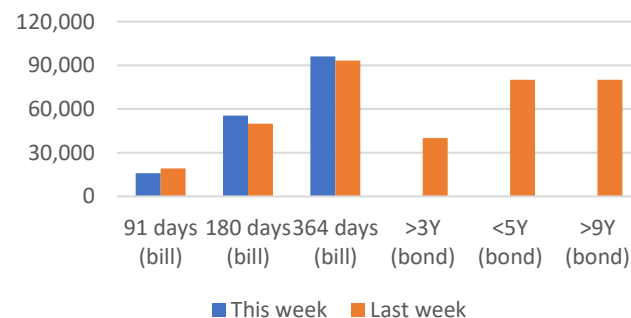

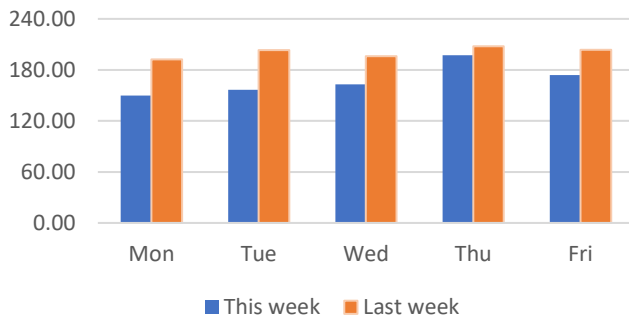
T-Bill/Bond Auction: Weighted Average Yields



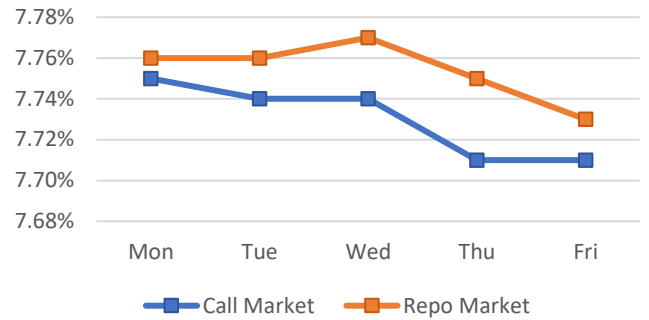
T-Bill/Bond Auction: Amounts Accepted



Overnight liquidity

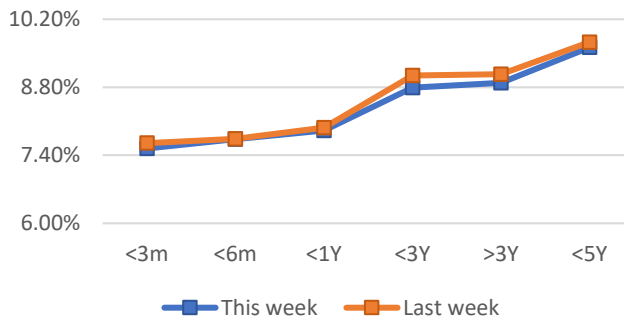


Money Market Weighted Average Yields

Secondary Market Yield Curve (Treasury)



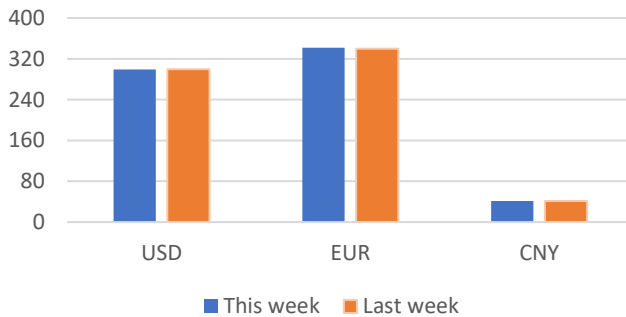

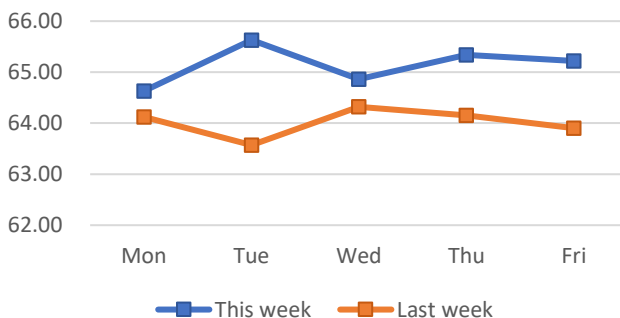

Major currencies against LKR

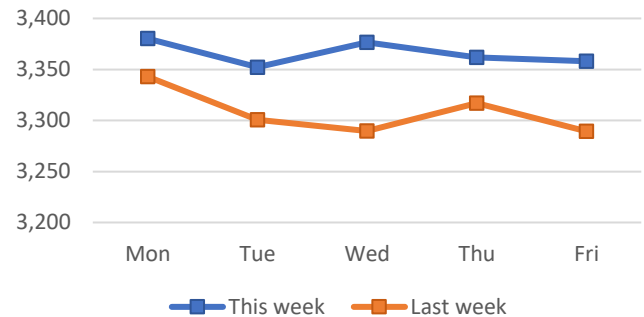

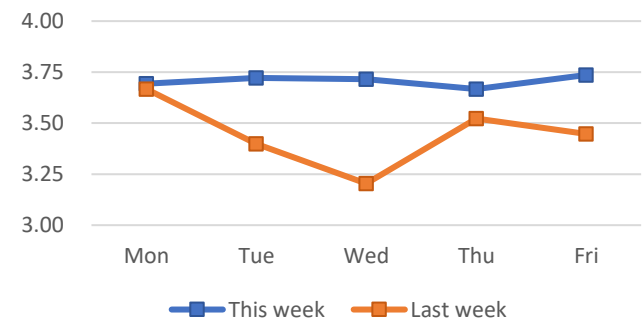
Brent Crude Oil Futures (USD)
